Failure to do so will result in immediate expulsion.
- Use of club grounds and equipment for picnicking, fishing, and shooting on ranges provided for that purpose.
- Participate in activities, including teams representing the association.
- Vote on issues except the expenditures of funds and club policy.
- Associate members may not hold elected office.
- Be responsible for the conduct of any invited guests, including spouse and children.
- Membership is valid from January 1 to December 31 of the year issued and is NOT transferable.
- Meetings are for MEMBERS only. Spouses, children, and other family members may not attend.
